

Before mentioned by him them to be done and performed or that shall be added

 imbedded in their former Estates in as full and ample a manner as if this
 Grant had never been made. And further it is Agreed that in case any
 Considerable Pond or Barren Mountainous Unimprovable Lands shall
 be found to lay within the Thirty Six Square Miles the same is not to
 be allotted out any thing before mentioned to the contrary notwithstanding
 unless the said Thomas Parsons shall consent thereto But shall remain
 the property of the Proprietors as in their Original Right with a
 proper Allotment of Land Adjacent to as to Admit of a free Access to
 such Ponds & Mountainous Land to be reported when a plan of the
 Township is skimed and the said Prop^r upon such Facts being duly
 Ascertained will make an Additional Grant for such deficiency reserving
 One fifth part of such Addition to their own use And the Grants
 Lots shall not be subjected to any Town or Parish Charges or Taxes
 of any kind neither by Act of the Great and General Court nor other
 ways until they shall be by them or their Assigns respectively settled
 and Improved But the said Thomas & his Associates shall keep & have
 them wholly indemnified therefrom And also that neither the Grantors
 nor their heirs shall by virtue of this Grant be bound or held to Warrant
 the said Granted premises to the said Thomas nor to his Associates or
 Assigns
